You have offered to plead guilty or noto contendere in this matter. Before accepting your plea, the court must be convinced that you understand the following.

- 1: If your plea is accepted, you will not have a trial of any kind and you will be giving up the rights you would have at a trial, including the right:
  - (a) to be tried by a jury;
  - (b) to be presumed innocent until proved guilty;
  - (c) to have the prosecutor prove beyond a reasonable doubt that you are guilty;
  - (d) to have the witnesses against you appear at the trial;
  - (e) to question the witnesses against you;
  - (f) to have the court order any witnesses you have for the defense to appear at the trial;
  - (g) to remain silent during the trial;
  - (h) to not have that slience used against you; and
  - (i) to testify at the trial if you want to testify.
